**NOTICE OF OBJECTION BY INTERESTED PERSON
AND APPLICATION TO THE BOARD TO BE SPECIFIED AS A PARTY
Under the Motor Vehicle Transport Act, 1987, and/or the Public Vehicles Act.**

INSTRUCTIONS:

The Public Vehicles Act authorizes an interested person to oppose an application for a public vehicle/extra-provincial operating licence, but only on the grounds that the interested person has an economic interest in the outcome of the proposed application.

The objection shall be filed within 29 days of the date of publication.

The objection must be served on the applicant and be filed with the Board. Proof that the objection has been served on the applicant must be provided to the Board.

Service and filing may be effected by hand delivery, mail, courier or facsimile.

Serving means the date received by a party and filing means the date received by the Board.

The objector must pay the appropriate fee payable to the Minister of Finance.

Fee schedules:

\$150.00	to oppose a permanent PVS application
\$250.00	to oppose a temporary PV/PVX application
\$100.00	to oppose a temporary PVS application
\$400.00	to oppose a PV/PVX transfer application
